Where possible choose a local production source to minimise the carbon footprint of the associated distribution burden.			
Implement a training program for its staff to raise awareness of environmental issues and enlist their support in improving the Company's performance.	Phil McDaniel - Partner	Especially focused on HGV drivers to increase truck fuel efficiency and reduce the environmental impact of ESS commercial vehicles in general. Send drivers on LGV CPC courses to get the latest advice on efficient driving.
